- m. **Advocacy Chair** Sheree Stoppel new State chair from Dodge City and is organizing everyone and giving out great ideas to move this position forward. Be more visible to all teachers as a support for anything. Finding an accompanist, money problems, program elimination, etc. Kelly Nedler is the State Chair that is really working to be more resourceful with this position.

VI. **ECKMEA** Website

- a. Troy Johnson Webmaster
 - i. Salary \$625 This is not a large salary for all that he does for us. Opened discussion about suggestions for amending this. Deb Hill moved that we raise Troy's base salary to \$1,000. Dan Freeman seconded this motion. Group voted and approved this pay raise for the 2018-2019 school year.
 - ii. Managed/Hosted Email Groups \$240
 - iii. Domain Name Renewal \$15 Total = \$880
- b. Use of Credit Cards at the District Level should schools be allowed to use credit cards to pay for registration and audition fees? As of now, State yes...districts no due to tax laws. Districts don't have credit cards set up for our bank account. ECKMEA might be the district that pilots this possibility. Credit card use will incur upcharges for Paypal fees, etc. Jennier Klinkenberg asked for a standard paragraph for chairs to use on websites to make sure verbiage is correct. Jennifer Klinkenberg motioned to pilot the credit card payment program. Will Biggs seconded this motion. Deb Hill brought up tax questions and Jennifer Klinkenberg asked if there would be a way for Exec Director to know who paid by credit card. Group voted and passed the motion to pilot the credit card program. Elise, please notify Troy Johnson about this new job.

VII. ECKMEA Handbook

a. Missing items – on pg 20 under Music Mentor Chairs, adding verbiage about the county laisons for Music Mentors as well as adding to their responsibilities the importance of maintaining a database for ALL music teachers in this geographical area.

Discussing whether or not we can add an additional choir chair for the new Treble Group. Logistically, the HS Choir Chair can't be with both groups at the same time. Band offered their solution that they find a willing director being a representative for the other group if we do NOT add a chair for the Treble Group.

Decided not to add a chair. The current HS Choir chair will appoint a Clinician's Assistant to help with the 2nd choir for District.

 - i. **District vs. State Policies** (hold true for all ensembles, all levels) Changed verbiage under section D. Meetings that the Summer Board meeting will be held after June Meeting.

Juli OMealey-Simmons asked if we should match what the State does in regards referring teachers/parents to policies.

Significant changes in the Honor Ensembles:

- 1. You must be a KMEA member to submit students
- 2. Students must be enrolled in class to audition
- 3. Registration deadlines (October, varies by band/orch or choir)
- 4. Audition fee going up to \$10
- 5. Invoice generator change to accommodate credit card, Elise updated to the invoice generator that will go on the website to reflect changes in groups this year.
- 6. Discussing amending the handbook so that Choral Audition entries will be accepted with a \$25.00 late fee. But Choral students who have late entries will NOT be eligible for State ensembles. Choral teachers would have to directly contact the HS Choir chair for late entries so that the chair can approve the late entries.
- 7. Adding verbiage for Act of God under G. All State Audition Eligibility.
- 8. Information Matt had for clinician fees and what's in the handbook are not the same. Working to make them the same. HS 300, MS 250, ES, 200 for choir groups.
- 9. Notes for Middle Level Choir specifically Freshman for choir, there will be a middle level and high school track. That track must be followed all the way to State in regards to auditioning.
- 10. Choral cuts will be announced by 8 am the day before
- 11. Instrumental Handbook states \$10, \$25, \$50 Late registration
- 12. Choral: Currently, no late entries accepted

Choral audition entries must be submitted by the **STATE DEADLINE** in order for students to be eligible to audition for the All-State Choirs (Mixed and Treble). Late entries are not accepted by the State.

However, late entries for District Choir <u>will be</u> permitted, when submitted in writing by an ECKMEA Choral Educator. This educator must contact the DISTRICT Choir Chair DIRECTLY via phone or email. Teachers who do not submit their students by the state deadline are only eligible to audition and participate in the ECKMEA <u>District Choir</u>. In addition, DISTRICT LATE FEES will be assessed for each student and must be submitted to the chair before a student will be allowed to audition (fees are found in the ECKMEA District Handbook).

- a. **Sight-Reading Excerpts** Marie Lerner-Sexton & approval of payment **Discussing the \$200 fee paid to the person who creates the choral sight-reading excerpts to include writing out policy procedures for this. Juli OMealey motioned to pay for a sight-reading consultant \$200 each year to create excepts for choir and to document (and use) the parameters for these sight-reading exercises. Sheree Stoppel seconded this motion. Motion passed.
- b. Act of God Policy add to state policy & now ECKMEA Policy CHAIRS: if district allows someone to perform, I will need you to send ME the names of any student who did not meet all state eligibility requirements.
- c. Can we accept the Handbook as presented today with the changes we've discussed? Will Biggs moved that we accept the Handbook as typed by Justin Love on his Macbook Pro. Dan Freeman seconded this motion. No discussion. Group voted and passed the Handbook.
