- A. Reminder to all: KMEA holds liability insurance through NAfME. This insurance covers lawsuits brought against leaders for decisions made as part of Board service. - B. All-State Live Instrumental Auditions will be held at Lakewood Middle School

- D. New Ensembles at the ISW this year.
 - All-State String Orchestra begins this year (2nd all-state orchestra)
 - I-2A Honor Band Begins this year.
 - Director Recommended group/not an all-state group
 - Will rehearse at the AMAC with the other all-state bands.
 - Will perform on Saturday
 - Students must audition for the EC honor band to be eligible (but do not have to make it). Director recommendation forms will be used to build the group. The roster will be created immediately following the release of the all-state rosters, so any I-2A students who earn all-state will perform with the all-state band.
 - Why? I-2A students rarely make it into the all-state groups. KMEA wants to provide an opportunity for these students to participate in the ISW and a full/big band. It also gives the teachers a better chance to attend the convention (a strong argument to present to admin). The state is now also considering a I-2A honor choir.
 - As a board, let's make sure our EC 1-2A schools know of this opportunity ASAP: Burlingame Lyndon Marais Des Cygnes Olathe Christian School Hyman Brand KC Christian Central Heights (Richmond) Metro Academy (Shawnee Mission) Maranatha Academy
- E. All-State Group Performances
 - BOTH Orchestras will be on Friday Evening (biggest change)
 - Choirs will be as they have been the past couple of pre-covid years (late morning/big convention hall)
 - Jazz Band I2A Band 56A Band I234A Band in the afternoon. (56A and I234A will rotate performance times each year)
 - As a result, ISW Thursday night is now a rotation: I year President's Concert, next year University Night. Friday is All-State Orchestras: String followed by Full.
 - All-State Orchestra Rehearsals may start earlier on Thursday. Keep an eye out for this info.
- F. All-State Groups Facilities:
 - Facilities will be similar to 2020 ISW. Bands (including I2A Band = AMAC, Choirs/Jazz at the Convention Center, Orchestras: not 100% sure, but I believe the Drury?)

- The AMAC is also reserved for Saturday morning, so the all-state bands will rehearse Saturday morning, and also get a final clinic with Dr. Tim or someone similar.
- Wichita public is being VERY helpful. Facilities are free as long as I Wichita student is in any one of the all-state groups. Equipment is also now taken care of by Wichita (all-state band percussion, for example.), and the rental rate is very good.
- Bus service to and from the AMAC is going to be increased. Keep an eye out for details.

November 6th – Live Auditions for High School Honor Groups

We are planning to be live. In addition to sight reading and equipment concerts (percussion), YouTube has updated their policies to include a "right to monetize" on ALL videos, including unlisted. Also, our blanket copyright grace period ended June 30th.

Location: GEHS

Reason for Live: Sightreading (difficult when recorded) and as of July I, YouTube has released right to monetize any video on their site, leading to possible ads during auditions

Still possible that we could do recorded based on COVID issues; decision date will be made on October 1st

Could do same or variation on what we did last year or could use Festival Scores (non-video) Non-video poses problems because of doctored recordings, so leaning towards YouTube (like we did last year) if the auditions are recorded

Will Biggs wants to know how many rooms are needed from HS chairs sooner rather than later Saturday, December 4th: District Mini Conventions

Choir: SMNW, Cassie Banion, Site Host

Band: BVH, Paul Bessetti, Site Host

REQUEST to each of the Chairs: Could you please email the executive board a copy of your complete schedule of the mini-convention day? For some reason, this isn't in our EC files, and we occasionally get the questions...

Commissioning project comes to fruition this year. Our Donors – Clay Blair and Niko Platko of the Clay Blair Foundation - would like to try to hear the premieres. Our current performance schedule will have all three premieres at almost exactly the same time. Band is the latest and they can probably make one of the others and Band.... Thoughts/discussion?

Check to see if the Olathe West site can be at 2:30 instead of 3:30 (Mindy/Jon/Orchestra Chairs will discuss and facilitate)

If we need to be spaced out, how do we do that logistically?

Would need to discuss a mask mandate at the various sites – need to adhere to the published guidelines

Reach out to various alternative host sites to allow honor groups to spread out? Lots of discussion on possible paths – additional sites, extended day, extra dates, smaller groups etc., but no decision made tonight. Executive Board will convene separately and come up with contingency plans that will be shared later.

- B. ECKMEA High School Scholarships
 - Reminder that we offer up to three \$750 scholarships for students studying music education, instate.
 - Last year, we discussed either pushing deadlines later, or having a runner-up for each award. Often, scholarships go unclaimed for a variety of reasons (not attending an in-state school, for example). Discussion?

Second/Third/Fourth...runners up will be selected. If this happens, an executive board member will present at the new recipient's school if possible.

- C. Reminder of Updates coming this year, approved by the board last year (and then delayed):
 - Honor Group registration fees moving to \$12 per entry at the initial registration time. No change to any other fees (late fees, etc).
 - Percussion Auditions will move to a "complete percussion audition". Board Discussion advised that we consider publishing the percussion "cuts" at an earlier date.
 Discuss at the business meeting in September
 If move to recorded audition, probably move back to previous setup (select which instruments you want to audition on) for this year and delay again
 - Jazz audition now requires improvisation. (Check to make sure it is in the handbook) (The All-State auditions also now require improvisation). Jazz Audition now using the new/revised all-state materials.
 - Our move to Video auditions was approved for Fall, 2020, only, with the intent to return to inperson.

Add possible language about COVID-19-related exclusions?

D. ACTION ITEM: HS Honor Group Auditions Staffing

- Since the EC/NE Split, EC has substantially fewer directors but is still auditioning almost the same amount of students. Fully Staffing auditions (3 judges, 2 door monitors in all rooms) has not been possible for the two years of in-person auditions. We barely made it last year when we were doing video auditions and were able to condense some positions.
- Currently, the director is required to attend auditions if they register any students, and a second director/adult is recommended if the school registers more than 20 students. We are still short

adults at auditions. Some help from colleges, but very inconsistent. Some private teachers are willing to help, but also very inconsistent.

- Additional discussion at last year's board meeting revised the proposal:
 - Make sure food is available to all workers.
 - Wording added to the proposal (below) to specify that this is a per ensemble requirement, not per building. (i.e you have 25 string auditions, 10 choral, and 30 band, then you bring 2 adults for strings, 1 for choir, and 2 for band.)
 - Wording added to define the timeline for applying the \$100 fee (giving time for directors to secure helpers).
 - General support of the idea was voiced by all (at last year's meetings) with the above updates.

Current Policy, page 26 of ECKMEA Handbook:

"I. Educator Participation: All ECKMEA members who register students to audition for an ECKMEA High School Honor Ensemble must assist with the audition process. ECKMEA Honor Ensemble Chairs are responsible for assigning all teachers who register students to audition, a task. Teachers who register 20 students or more should bring an additional adult to assist with auditions. Whenever possible this extra adult should also be a music teacher, such as an assistant director or colleague. The ECKMEA President must approve exceptions to this policy. Schools found not to be in compliance will be assessed a \$100 fine."

Recommended update, page 26 of ECKMEA Handbook. Italicized print is the update.

"I. Educator Participation: All ECKMEA members who register students to audition for an ECKMEA High School Honor Ensemble must assist with the audition process. ECKMEA Honor Ensemble Chairs are responsible for assigning all teachers who register students to audition, a task. For each 20 registered auditions in each performance area (Band/Jazz, Choir, Orchestra), the school must bring an additional adult to assist with auditions. Example: Auditions I-20 – director must attend. 21-40 a second adult (assistant director if possible). 41-60 a third adult (student teacher/another colleague), and so on. Whenever possible this extra adult should also be a music teacher, such as an assistant director, colleague, or student teacher. Parents can also help and will be assigned to door monitoring duties so our professional educators can serve as judges.

Example: School A has 10 Choral Auditions, 25 Orchestra, and 30 Band/Jazz. This school would provide 1 adult for Choral Auditions, 2 for Orchestra, and 2 for Band/Jazz.

Initial registration numbers will be used to determine number of adults per school/per audition area.

All adults will be assigned jobs by the honor ensemble chairs. Any school that cannot provide their allotment of adults will pay a \$100 fee for each unfilled position. This fee will be used to hire professional judges (private teachers, etc.) at the rate of \$100 for the day.

Timeline: All Adult Helpers will be reported to the respective Honor Ensemble Chair by the Friday 8 Days prior to the Live Audition Date. Following that deadline, the \$100 fee will be assigned to all schools and honor ensemble chairs will work with the executive director to hire professional judges.

The \$100 per position payment will be due prior to the December Mini-Convention.

The ECKMEA Executive Board must approve any exceptions to this policy.

 - Wichita public is being VERY helpful. Facilities are free as long as 1 Wichita student is in any one of the all-state groups. Equipment is also now taken care of by Wichita (all-state band percussion, for example.), and the rental rate is very good.
- F. Coming Soon at ISW:
 - Second All-State String Orchestra. Details will be presented at the July Meeting from KASTA. If approved it will go into place for the 2022 ISW
 - A 1-2A ISW Band not an all-state group. 1 Day only. Director recommendation group. Why? To provide a great experience for students who may never be in a full concert band and to encourage ISW attendance for 1-2A teachers.

- A. ECKMEA Meeting Dates for 2020-21:
 - September 8th, 2020: Annual ECKMEA Fall Business meetings and breakouts. GEHS. At this time planned to be in person but could easily change to zoom. Will be discussing dinner (probably need to move to a boxed dinner).
 - Honor Group Audition Date is Saturday 11/7, GEHS. Discussion of moving to recorded auditions below (notes below as well)

- Mini Conventions are Saturday, December 5th

 - Band: BVH, Paul Bessetti, Site Host
 - Orchestra NEW SITE Olathe West High School. JJ Wallace, site host.
- B. ECKMEA High School Scholarships
 - Reminder that we offer up to three \$750 scholarships for students studying music education, in-state. Applied for in Nov, awarded in Dec.
 - Jon Duncan Is there are reason not to award them later in the year to guarantee we give it to someone who is eligible (in-state, music ed major)
 - Philip Kaul What about designating runner-ups for each scholarship?
 - Executive Committee will discuss, may push an electronic vote
- C. ACTION ITEM: Honor Group: HS Auditions Registration Fee and Middle Level/Elementary Honor Groups Registration Fee.
 - Our only source of income.
 - Rising Expenses:
 - Addition of Nurses and Security at Mini-Conventions (was supposed to be added in 2019 but could not afford).
 - 2019: Scholarship raised to \$750 per each of three. (\$1500 total increase)
 - Music and other costs have gone way up the past two years.
 - a. Absolutely no copied music. We now buy at least 2 copies of most pieces. No longer renting pieces.
 - There is currently "extra" money in our account right now because of the commission projects choir and band are doing this fall.
 - There are no "participation fees" in ECKMEA some districts use this. Benefit to this proposal is to just increase what's in place, not adding a whole round of fee collection.
 - Our fees go directly to chairs. Adding another fee would make their lives much more difficult.
 - The executive board recommends a \$2 raise in Registration fees for all ECKMEA groups to \$12. There will be no raise of late fees.
 - Motion Needed. If it passes Handbook update will be needed.
 - Motion: Joel Wagoner
 - Second: Courtney Nichols
 - Discussion (see above), Motion Passes Unanimously
- D. ACTION ITEM: HS Honor Group Auditions Staffing:
 - Since the EC/NE Split, EC has substantially fewer directors but is still auditioning almost the same amount of students. Fully Staffing auditions (3 judges, 2 door monitors in all rooms) has not been possible for the past two years.
 - Currently, the director is required to attend auditions if they register any students, and a second director/adult is recommended if the school registers more than 20 students. We are still short adults at auditions. Some help from colleges, but very inconsistent. Some private teachers are willing to help, but also very inconsistent.
 - The executive board recommends the following update to current policy. If approved, the handbook will be updated accordingly.

- Choral (Duncan) and Orchestra (Wiebe) voiced similar concerns as band (although less intense). In agreement that the additional help is beneficial. Food will be available for all adult volunteers.
- Additional wording to specify additional adults needed per ensemble, not as a building.
- When is the fee applied? Include a window from registration until invoice to allow directors time to find additional staffing
- Do we need language about cancellations (illnesses, travel problems, etc.)?
- Loose approval of the idea nonverbal signals, item is tabled while Dan invests some time reworking proposal with a goal of implementing this year pending an electronic vote

Current Policy, page 26 of ECKMEA Handbook:

"I. Educator Participation: All ECKMEA members who register students to audition for an ECKMEA High School Honor Ensemble must assist with the audition process. ECKMEA Honor Ensemble Chairs are responsible for assigning all teachers who register students to audition, a task. Teachers who register 20 students or more should bring an additional adult to assist with auditions. Whenever possible this extra adult should also be a music teacher, such as an assistant director or colleague. The ECKMEA President must approve exceptions to this policy. Schools found not to be in compliance will be assessed a \$100 fine."

Recommended update, page 26 of ECKMEA Handbook:

"I. Educator Participation: All ECKMEA members who register students to audition for an ECKMEA High School Honor Ensemble must assist with the audition process. ECKMEA Honor Ensemble Chairs are responsible for assigning all teachers who register students to audition, a task. *For each 20 registered auditions, the school must bring an additional adult to assist with auditions. Example: Auditions 1-20 – director must attend. 21-40 a second adult (assistant director if possible). 41-60 a third adult (student teacher/another colleague), and so on. Whenever possible this extra adult should also be a music teacher, such as an assistant director, colleague, or student teacher. Parents can also help and will be assigned to door monitoring duties so our professional educators can serve as judges. All adults will be assigned jobs by the honor ensemble chairs. Any school that cannot provide their allotment of adults will pay a \$100 fee for each unfilled position. This fee will be used to hire professional judges (private teachers, etc.) at the rate of \$100 for the day. The ECKMEA President must approve exceptions to this policy.*

- E. ACTION ITEM: 2020 ECKMEA High School Honor Group Auditions. Proposal to move to video recorded auditions for the Fall of 2020 due to Covid-19 realities.
 - See APPENDIX C for full proposal.
 - Discussion and vote needed.
 - This is a 1 year proposal that will only affect next year

Matt Bradford points out that, generally, auditions are recorded and submitted, but the judging will still be LIVE. No students or parents are present during the judging. In answer to Courtney Nichols' question, Dan Freeman explained the door monitor runs the recordings, so the auditions are still 'blind'. Other districts are considering it (a few already do recorded instrumental auditions). We are the only one looking to do across the board recorded auditions.

Dan Freeman asks for input about choral and orchestra procedures (how many video submission would be preferred), the details will be worked out later, see appendix C.

Courtney wants to know how to tie registration info in Troy's system to videos

- Info within the google form would allow chairs to ensure videos are tied correctly
- Phillip Kaul Populating audition numbers to google forms is very doable

- Details to be worked out in future meetings

Troy is sending details to Dan about tweaking/eliminating submission deadlines

Side discussion about teacher's role in recording submissions. Jon Wiebe floated the idea of teachers 'proctoring' recording --- makes it more consistent and similar to the audition experience. A number of members (Joel Wagoner and Phillip Kaul) expressed concerns about ability of teachers to manage this, as well as the benefit for the invested work.

Procedural Notes:

- No resubmissions. First timestamp is the audition we take.
- Include "day of contact" to try to get another link day of if there is a problem with submission
- Troy recommended desktop speakers for all computers being used for playback, Will Biggs pointed out GEHS has same speaker set up in all rooms.
- Matt Bradford all videos need to be formatted the same way (hence the youtube or vimeo)

Side discussion prompted by Jon Duncan about tabling the decision about sight reading to allow the chairs to explore options. Phillip Kaul suggests this would require a teacher to proctor the sight reading (like what we've done for kids who participate in Nafme events that conflicted with our past auditions). Bradford: Historically had an issue with alleged dishonesty by a teacher. Would suggest we avoid the situation

Chairs all agree to keep the proposal as written (no sight reading)

Motion to move to video audition structure based on appendix C. Motion: Jon Duncan Second: Jon Wiebe Discussion (see above) Motion passes unanimously

- F. Please remind your teachers that dual auditions are not allowed. High School Students must select only one area to audition Band/Choir/Orchestra. Exceptions are:
 - Orchestra and Band Students may audition for Jazz Band. Preference declared on registration form.
 - Band students may audition for multiple instruments (example: piccolo and flute). Preference declared on registration form.
 - No other exceptions allowed.
- G. Deadlines for Non-Audition Honor Groups
 - ML Band October 13th
 - Elem, ML Choir October 15th
 - Elem, ML Orchestra: October 28^{th.}

Sarah Shipley brought up a question of submission deadlines and how strict enforcement should be. Several floated the idea of a late fee, Troy explained rosters for the ensembles start to be made immediately after the deadline (since there are no auditions). It wouldn't make sense to ask chairs to add performers to a roster that is already being

formed. Dan Freeman suggested moving the deadlines later in the month. Each chair agreed that they would prefer to keep the current format.
