1. Matt Bradford, ECKMEA Executive Director

A. Treasurers Report

- Financial status—we are doing very well, we have more money than most other districts around the state, does cause us to pay more to the State Auditor
- \$28,885.03 current balance in our account
- Investment Company Kirkpatrick Investment Group" (Wells Fargo) in Topeka have a current Balance of \$26,802.67
- 2023 Yearly cost
 - Deposits-\$32,494.70
 - Cost-\$36,058
- B. I propose we start using Festival Auditions to manage our live auditions. I would like us to discuss this tonight.

- The Festival Auditions system will be priced at the following rates beginning with the 2023-24 school year:
- 15c per judge scoring record
- OR
- 75c per audition entry
- The final service invoice will be configured to charge the lower amount once the math is worked out. For example, let's say you have the Trumpets go through two rooms with three judges in each room. That would be six judges scoring each entry. For each trumpet that would create a value of \$0.90 per entry, if the service charge were based on scoring records. Otherwise, it would default to the lower rate of \$0.75 per entry. Other sections that might have one room with three judges would create a value of \$0.45 per entry.
- The final service invoice for each account will do the math across the entire audition event and calculate all scoring records. Then it will count the total number of entries. Whichever calculated value is lower would be your final service charge.
- Each chair would have a separate admin account (band, choir, strings, jazz). Although Jazz might not need it if their numbers are low. The State Jazz Chairs did not use FA at ILA last January. They ran their auditions the old-fashioned way. Only the band and strings chairs were using FA at that event.
- Once you have a list of split rooms, as well as the number of judges per room, I would be able to run a full estimate against your past audition registration data.
